



Scholarship Application

The Award:

The New Jersey Credit Union League's Youth Involvement Board (YIB) scholarship is an award of up to \$1,000 to be paid jointly to the winning student and the chosen accredited educational institution.

Eligibility:

The applicant must be a member in good standing of a participating credit union and must be enrolled as a high school senior at the time of application.

Scholarship funds must be used: (1) for tuition or textbooks; (2) only at an accredited educational institution. (2 or 4 year college, university, or trade school)

Application Process:

Eligible members must complete this scholarship application. A student may submit only one application. In the event a student submits more than one application (for different individual credit union scholarships) only one application will be considered.

- 1. The application must be signed by a management-level official of the student's participating credit union to verify eligibility.**
- 2. The signed application must be submitted with:**
 - An official high school transcript. Transcript must be **NON-WEIGHTED** on a 4.0 scale.
 - A SAT/ACT transcript provided through your high school guidance office.
 - The Teacher Reference Portion of the application must be completed by one of the applicant's teachers and returned in a sealed, signed envelope.
- 3. Return the application, transcript and reference to your credit union by the application deadline. If any portion of the application is incomplete or not included, your application will be disqualified.**

Selection Process:

Judging will be based on academic performance, extracurricular and community activities, references, and personal goals. Credit unions will be notified of scholarship winners by May 21, 2010.

Application Deadline:

Students must return applications to their credit union on or before April 2, 2010.

Application Verification:

For Credit Union Use Only: Application will not be considered unless this section is completed in full by sponsoring credit union management.
